## 4) NOTIFICATIONS AND DECISIONS

**After the match between HC Vojvodina - HC Tatra, by the President of the Commission for monitoring referees and controllers of Handball Association of Serbia Mr. Živan Stakić and SEHA League Commissioner Mr. Marjan Nachevski, has been made expertise of the match and it was concluded that the referees of the match refereed the match very well and all imposed fines and disqualification in the game are consistent with the rules of handball games.**

At the match of 12<sup>th</sup> round between HC PARTIZAN and HC MESHKOV BREST, played in Beograd, Meshkov Brest player Ivan Karačić was disqualified in 48<sup>th</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.1. of the Competition Regulations, SEHA League Commissioner brought up the following

### **DECISION**

**HC MESHKOV BREST player Ivan Karačić is fined 100 €**

At the match of 12<sup>th</sup> round between HC VOJVODINA and HC TATRAN, played in Novi Sad, HC Vojvodina player Uroš Elezović (No.8) was disqualified in 34<sup>th</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.3 of the Competition Regulations, SEHA League Commissioner brought up the following

### **DECISION**

**HC Vojvodina player Uroš Elezović is punished that he should not play one game.**

The penalty relates to the first next match.

Due to the resulting disqualification **Uroš Elezović was fined 500 €**

At the match of 12<sup>th</sup> round between HC VOJVODINA and HC TATRAN, played in Novi Sad, HC Vojvodina player Jožef Holpert (No.32) was disqualified in 10<sup>th</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.1. of the Competition Regulations, SEHA League Commissioner brought up the following

### **DECISION**

**HC VOJVODINA player Jožef Holpert is fined 100 €**

At the match of 12<sup>th</sup> round between HC VOJVODINA and HC TATRAN, played in Novi Sad, HC Tatlan player Žarko Pejović (No.23) was disqualified in 41<sup>st</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.1. of the Competition Regulations, SEHA League Commissioner brought up the following

**DECISION**

**HC TATRAN player Žarko Pejović is fined 100 €**

On December 8<sup>th</sup> 2013. in Novi Sad was played match of 12<sup>th</sup> round between HC VOJVODINA and HC TATRAN. For failure to send a match report promptly after the game, according to Article 77 of the Competition Regulations SEHA League Commissioner brought up the following

**DECISION**

**HC VOJVODINA is fined 150 €**

At the match of 6<sup>th</sup> round between HC BORAC m:tel and HC MESHKOV, played in Banja Luka, HC Borac m:tel player Srđan Trivundža (No.23) was disqualified in 47<sup>th</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.3. of the Competition Regulations, SEHA League Commissioner brought up the following

**DECISION**

**HC BORAC m:tel player Srđan Trivundža is punished that he should not play one game.**

The penalty relates to the first next match.

Due to the resulting disqualification **Srđan Trivundža was fined 500 €**

At the match of 10<sup>th</sup> round between HC VARDAR and HC METALURG, played in Skopje, HC Metalurg player Pavel Atman (No.19) was disqualified in 60<sup>th</sup> minute of the game.

Due to the resulting disqualification, in accordance with Article 99.3. of the Competition Regulations, SEHA League Commissioner brought up the following

**DECISION**

**HC METALURG player Pavel Atman is is punished that he should not play one game.**

The penalty relates to the first next match.

Due to the resulting disqualification **Pavel Atman was fined 500 €**

For the incident caused in 51<sup>st</sup> minute of the match between HC Vardar and HC Metalurg, played in Skopje on 17<sup>th</sup> December, 2013., by HC Vardar spectators (throwing objects – coins to HC Vardar player No. 31 - Timur Dibirov), in accordance with Article 70.1 of SEHA League Proposition, SEHA League Commissioner brought up the following

**DECISION**

**HC VARDAR** is punished with a fine of **500€** (fivehundredeuros)

**Explanation:**

On 27<sup>th</sup> December 2013. we received an additional match report from match delegate Mr. Aleksandr Grechin on match between HC Vardar and HC Metalurg played in Skopje

Because the match delegate arrived home three days after played match (airport in Skopje was closed due to fog) and Christmas holidays in Croatia, above decision was made afterwards
