Reviewing the photos from the Final Four match between HC Tatran and HC Meshkov, held in Novi Sad, on April 11<sup>th</sup> 2014. it was found that HC Meshkov player Maxim Babichev (shirt No.6) was not dressed in accordance with Article 8 paragraph 14 of Competition regulations.

Due to above omission, League Commissioner brought up the following

#### DECISION

#### HC MESHKOV is fined 200 € (twohundredeuros)

#### LEGAL REMEDY NOTE:

To the decision of the Commissioner of the league it is possible to appeal to Competitive Commission as an appellate authority, within 24 hours of receipt of the decision, in accordance with Article 42 of the Regulations SEHA League.

With the appeal should be paid a fee in the amount of € 1,000 to the account of HRS with note "SEHA League", according to Article 43 of the Regulations SEHA League.
