4) NOTIFICATIONS AND DECISIONS

At the match of 5th round between HC VARDAR and HC PPD ZAGREB, played in Skopje, PPD Zgreb player Tonči Valčić was disqualified in 54th minute of the game.

Due to the resulting disqualification, in accordance with Article 99 of the Competition Regulations, SEHA League Commissioner brought up the following

DECISION

HC PPD Zagreb player Tonči Valčić is fined 100 €

On September 30th, 2014. in Skopje was played the match of the 5th round Seha Gazprom South Stream League between HC Vardar and HC PPD Zagreb. After a supplemental statement of the SEHA League delegate, due to the breach of Article 101, paragraph A, (no live score after 23rd minute))League Commissioner has decided as follows:

HC Vardar is punished by a fine of 200 € (twohundredeuros)

After a supplemental statement of the match delegate mr. Sandor Andorka on match HC Vardar - HC PPD Zagreb, played in Skopje on 30.09.2014., because the audience ignited a torch in the auditorium, in accordance with Article 97.3 of SEHA League Proposition, SEHA League Commissioner brought up the following

DECISION

HC VARDAR is punished with a fine of 500€ (fivehundredeuros)

After a supplemental statement of the match delegate mr. Sandor Andorka on match HC Vardar - HC PPD Zagreb, played in Skopje on 30.09.2014., because spectators threw flares into court, in accordance with Article 97.4 of SEHA League Proposition, SEHA League Commissioner brought up the following

DECISION

HC VARDAR is punished with a fine of **1.000€** (onethousandreueuros)
