## 4) NOTIFICATIONS AND DECISIONS

At the match of  $18^{th}$  round between HC PPD ZAGREB and HC MKB-MVM VESZPREM , played in Varaždin, on March  $1^{st}$ , 2015., HC Meshkov player Christian Zeitz was disqualified in  $50^{th}$  minute of the game.

Due to the resulting disqualification, in accordance with Article 99.3 of the Competition Regulations, SEHA League Commissioner brought up the following

#### **DECISION**

- HC MKB-MVM Veszprem player Christian Zeitz is fined 500 €
- HC MKB-MVM Veszprem player Christian Zeitz is punished that he should not play one game.

(The penalty relates to the first next match)

At the match of  $14^{th}$  round between HC BORAC m:tel and HC TATRAN , played in Banja Luka, on February 13th, 2015., HC BORAC m:tel player Petar Jokanović was disqualified in  $16^{th}$  minute of the game.

Due to the resulting disqualification, in accordance with Article 99.1 of the Competition Regulations, SEHA League Commissioner brought up the following

#### **DECISION**

HC BORAC m:tel player Petar Jokanović is fined 100 €

On the occasion of the controversial moment of the match Metalurg – Vojvodina, played 07.02.2015. year in Skopje, in accordance with Article 9.5, 31.7 and Article 38.1 of the SEHA Gazprom South Stream league Regulations, and by obtaining and reviewing all supplemental statement, SEHA League Commissioner hereby issue the following:

#### **DECISION**

- 1. The **goal** that was scored by a RK Vojvodina player in 59:56 minute is **not regular**, because the game was interrupted three seconds before ball was kicked towards the goal
- Because of unauthorized entry in court HC Metalurg coach Lino Červar is imposed by a warning, in accordance with Article 38.1. of the SEHA Gazprom South Stream league Regulations.
- 3. Due to not timely sanction, with a progressive penalty, HC Metalurg coach Lino Červar for entry into the court, **delegate Siniša Rudić** is imposed by a **warning**, in accordance with Article 38.1. of the SEHA Gazprom South Stream league Regulations.
- 4. Due to not timely sanction, with a progressive penalty, HC Metalurg coach Lino Červar for entry into the court, **referees Dalibor Jurinović** and **Marko Mrvica** are imposed by a **warning**, in accordance with Article 38.1. of the SEHA Gazprom South Stream league Regulations.

#### **JUSTIFICATION**

On February 16<sup>th</sup>,2015, director of the HC Vojvodina Mr. Darko Jevtic send me the video clip of the last minutes of the match Metalurg and Vojvodina played in Skopje on 07.02.2015 year.

In the next few days I have received several requests for review of video clip and statement regarding controversial moment of the game.

After collecting additional statements, pursuant to SEHA League Regulations for the season 2014/2015., the above decision was brought.

## **LEGAL REMEDY NOTE:**

To the decision of the Commissioner of the league it is possible to appeal to Competitive Commission as an appellate authority, within 24 hours of receipt of the decision, in accordance with Article 42 of the Regulations SEHA League. With the appeal should be paid a fee in the amount of € 1,000 to the account of HRS with note "SEHA League", according to Article 43 of the Regulations SEHA League.
