Obligation for all handball clubs

Article 62

The host shall no later than 120 (one hundred and twenty) hours prior to the beginning of the match notify the **Office of the SEHA League** (b.filipovic@hrs.hr), the visiting team, the referees, the delegate and the Commissioner in writing about the date and start time of the match.....
